- The Quality of Life Committee met in February and hosted a presentation with State Representative Francesca Hong about Governor Evers budget proposal and how it will affect small businesses downtown.
- DMI participated in a meet and greet with the new leadership of the Madison Police Department's Central Precinct.
- Peggy Gunderson and Nick Newlin from the BID Board hosted a discussion on downtown marketing with several organizations. The group is working on how we can market the downtown together.

Inclusiveness:

- After hosting an open discussion at their last meeting, the leadership of the Inclusiveness Committee met to discuss the future of the committee, it's focus and how often it will meet.
- The Beyond Compliance Committee continues their work with the City on how to assist Streatery users with their outdoor spaces.

Government Relations:

- DMI is conducting endorsement interviews for all 20 Common Council races and the Mayoral contest.
- To date, 35 out of 36 candidates eligible are seeking DMI's endorsement.
